I/We acknowledge that time is of the essence in filing my/our bankruptcy petition.

He has explained to me/us that the bankruptcy petition cannot be filed until the entire amount of the attorney's fees are paid in full, the filing fee is paid in full (if applicable), and the credit counseling fee has been paid in full. He has further advised me/us that the bankruptcy petition cannot be filed on the same date which the credit counseling certificate is dated. He has further advised me/us that if I/we do not provide him all of the documents which has requested, he cannot finish preparing the bankruptcy petition and cannot file it. Consequently, this will delay the protection of the automatic stay necessary to prevent any foreclosure, repossession, and any other collection efforts by any of my/our creditors.

I/We hereby further acknowledge and understand that until the bankruptcy petition is filed, I/we am not under the protection of the automatic stay, and the creditor(s) can still pursue any and all collection efforts, including, but not limited to, repossession, foreclosure, filing a lawsuit, and garnishment.
